## In addition to essential qualification, the Committee decided to adopt the following criteria for shortlisting purposes:

At least M.Tech in any Electrical/Electronics Engineering discipline or any Computer Science/Neuro-cognitive Science Discipline with at least 55% marks {% marks = CGPA (on a 10-point scale \*10)}.

At least 5 years relevant experience (cumulative).

At least 3 years relevant experience after M.Tech.

Based on the adopted criteria mentioned above, **18** candidates have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application.
