**Subject:** Regarding recruitment for the post of Production Assistant (Level-5) at IIT Delhi.

The Institute vide Advt. No. Mission Mode (DR) (1) / 2023 dated February 02, 2023, invited online applications for filling-up 05 posts (i.e. 04-UR & 01-OBC) of Production Assistant in Level-05 of Pay Matrix as per 7th CPC for ETSC, IIT Delhi. The Shortlisting Committee has scrutinized the applications of the candidates in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria was mentioned in the advertisement:

**Essential:**

Bachelor's Degree in Science/Computer Science/Computer Applications or equivalent with at least 55% marks in the qualifying degree or equivalent.

**OR**

Three Years Diploma or equivalent, in relevant field, with at least 55% marks with 02 years relevant experience.

**In addition to essential qualification, the Committee decided to adopt the following criteria for shortlisting purposes:**

A Bachelor's degree in any Electrical / Electronics Engineering discipline or any Computer Science/Neuro-cognitive Science Discipline. Acceptable degrees are B.Tech/B.E./MCA/M.Sc (CS or EE) or B.Des. In the case of MCA and M.Sc, the candidate should have done his/her B.Sc with a significant exposure to Maths and Science subjects. B.Sc + MCA is a valid combination, but just a B.Sc. or BCA or a Diploma/ITI is not acceptable. The total duration of Bachelor's level study should be at least 4 years (as is the case with B.E. or B.Sc + MCA).

At least 55% marks in the last Bachelor's degree (B.Tech/B.E/B.Des/MCA/M.Sc) is required.

Based on the adopted criteria mentioned above, **55** candidates have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that candidates have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof.
