**Subject:** Regarding recruitment for the post of Medical Officer (Dental) at IIT Delhi.

The Institute vide Advt. No. Mission Mode (DR) (1) / 2023 dated February 02, 2023, invited online applications for filling-up 01 post (i.e. 01-UR) of Medical Officer (Dental) in Level-10 of Pay Matrix as per 7th CPC for Hospital, IIT Delhi. The Shortlisting Committee has scrutinized the applications of the candidates in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria was mentioned in the advertisement:

**Essential:**

BDS including completion of compulsory rotating internship followed by at least 03 years of experience in a recognized hospital.

Should be registered with any State Dental Council or Tribunal in India.

**Desirable:**

(i) MDS in an appropriate Dental branch.

**OR**

(ii) Postgraduate Diploma in an appropriate branch of Dental with at least 01-year experience in a recognized hospital.

**OR**

(iii) The work experience should be in a medical college or large Govt. / recognized private Hospital.

**In addition to essential qualification, the Committee decided to adopt the following criteria for shortlisting purposes:**

1. 55% Marks in BDS + 07 years' Experience.

**OR**

2. 55% Marks in MDS + 04 years' Experience.

Based on the adopted criteria mentioned above, **34** candidates have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that candidates have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof.
